Foreword from the Independent Chair & Scrutineer



A warm welcome to this Autumn edition of the RSCP newsletter. The last meeting of the Redbridge Safeguarding Children Partnership (RSCP) took place on 14 October, the focus of which was on reviewing the current Multi-Agency Safeguarding Arrangements (MASA) following the new requirements of Working Together 2023. The meeting considered the structural changes required but also the values of the RSCP and listened to presentations on areas which the RSCP has identified they would like to develop, work already taking place and new roles and responsibilities. These included a children's rightsbased approach; addressing inequalities in safeguarding; the Families First for Children Multi-Agency Pathfinder; strengthening the role of education in multi-agency safeguarding; and the proposed new MASA model.

Partners considered the following: what are the strengths (or working well) in the current Redbridge MASA and don't need to change?; What are the opportunities in the new proposed MASA that would lead to improvements in response to what has been shared today? (i.e. child's rights-based approach; responding to disproportionality; the opportunity of the Pathfinder); and How will we know that the MASA are making a difference to children and young people?

Feedback from the discussions has been considered and have informed the drafting of the new MASA arrangements from 2025, and revision of the vision and values of RSCP which will be published in December 2024. More feedback from the meeting can be found on page 2.

Back to our newsletter, and his edition is focusing on the NSPCC safeguarding resources available for schools. However not all children attend an educational setting. The National Child Safeguarding Practice Review Panel produce a briefing in earlier this year on Safeguarding Children in Elective Home Education, to share learning from analysis of rapid reviews and local child safeguarding practice reviews (LCSPRs) to inform the work of safeguarding partners generally to help and protect children who are electively home educated. Most children who are home educated have happy and safe lives, but a small minority do not. Children who are educated at home and where there is a risk of abuse and neglect, will not be able to benefit from the protective care that school can provide.

Children who have never been to school are especially at risk of becoming invisible, rendering agencies much less able to act to protect them when necessary. The briefing calls for the government to increase and clarify the scope and responsibilities of local authorities, including through the establishment of a national register to ensure that there is knowledge about which children are being electively home educated.

As safeguarding partners we must take all necessary steps to assure ourselves that policy, practice, and procedures in all areas enables professionals to work effectively together, with children and their

families, to safeguard and protect this group of children.

The Panel has also recently issued advice on terminology and language in safeguarding reviews. The language used when referring to children, their families and communities can at times be contested and interpreted in different ways. Preferred terms can develop and change quickly.

As far as possible, the Panel try to use person-centred language to foster understanding, dignity and recognition of the full range of children's identities. For example, the Panel would use the term 'Black and other minoritised communities' when referring to communities affected by inequality related to their ethnic and racial heritage. The Panel use this term because it is important to recognise that experiences and challenges can vary for individuals with different ethnic or racial heritages. The Panel think that use of this inclusive language can support work to address the specific issues faced by various communities whilst also emphasising the common goal of promoting equity and addressing disparities.

Finally, please take the time to view the new MASA arrangements, and the revised Vision and Values statement that reflects the commitment the RSCP has made to safeguard children in our Borough, once published.

Feedback from the RSCP Meeting – 14 October 2024

Summary of items discussed at the last RSCP meeting In addition to the presentations and discussions mentioned in the Foreword, the RSCP received the following updates and information:

- Feedback on the launch of the new joint Data Subgroup with the Redbridge Safeguarding Adults Board (RSAB), which is chaired by the Local Authority.
- The RSCP safeguarding dataset for Quarter 1, 2023 2024.
- Received a copy of the latest edition of the Redbridge 'One Panel' Case Referral Log, which lists the cases that are referred into the Panel, the decision-making in relation to these and the outcomes in terms of case reviews. A local Child Safeguarding Practice Review (CSPR) is commencing in November 2024. RSCP Safeguarding Priorities 2023 - 2024

Priority 1

Contextual Safeguarding

A multiagency review of Contextual Safeguarding was undertaken in 2022 - 2023. Partners have agreed an action plan developed to respond to the learning and recommendations made. CSPRs, DHRs and SARs have also provided learning to be taken forward in respect of Contextual Safeguarding, developing a recognition of allage/system learning from incidents and case reviews.

The priority will be to ensure the findings of the Redbridge multi-agency Contextual Safeguarding Review, alongside local data and research, considers and responds to the findings from:

- HMICFRS MPS Inspection Putting Vulnerable Children at Risk, 2023
- Missing Children in London, London
 Assembly Police and Crime Committee
 Report, 2023

We will need to ensure arrangements are in place to appraise and respond to the recommendations of the review and have oversight of the progress on implementation of the recommendations.

The current plan is to provide a learning event for Redbridge professionals and volunteers in conjunction with the Redbridge Safeguarding Adults Board (RSAB) and Redbridge Community Safety Partnership. A multi-agency working group has been established to take this forward.

Priority 2

Children & Young People's Mental Health

It was established last year that work was needed on raising awareness of different support and resources available for children and young people with mental health needs and to test out whether service provision is meeting those needs.

A number of Rapid Reviews and local Learning Reviews on adolescent suicides have provided learning.



Action will focus on challenging accessibility and ensuring understanding of the service offer by parents/carers, young people and front-line professionals.; scrutinising agency evaluation and feedback from referrals into mental health services.

There will be a review of the quality of multiagency working for children experiencing challenges with their mental health, including a 'round table' audit event being facilitated by a multi-agency Task and Finish group in November.

Priority 3

A Suitable Home for Every Child

Current housing crisis, both nationally and acutely felt in LB Redbridge (4,442 children in temporary accommodation placed by Redbridge at the end of June 2023). Temporary accommodation can be a stable long term home but less so for children in B&B and hostel type accommodation.

Ensuring the prevention of homelessness duties are promoted across the Partnership.

Articulating the response across the Partnership for families that are badged as making themselves intentionally homeless or no recourse to public funds but have vulnerable children.

To review the effectiveness of multiagency arrangements to ensure continuity and support for those children who are likely to experience frequent changes in accommodation moving in and out of the Borough.

Focus on ... NSPCC

NSPCC have a range of free resources to help schools safeguard children. See below for a whistlestop tour of just some of what is available for primary and secondary settings.

Primary Settings

The NSPCC has reached over 90% of all UK schools with the **Speak Out Stay Safe Campaign**.

How are the Speak Out Stay Safe assemblies delivered?

With the help of celebrities, Ant and Dec, the child friendly, age-appropriate assemblies and workshops help children understand their right to be safe, to be listened to and receive help if they are worried.





It helps them understand:

Abuse in all its forms and recognise the signs, including online abuse and neglect;

That abuse is never a child's fault, and they have the right to be safe;

Know how to get help, and the sources of help available to them,

including safe adults in and outside school and Childline.



There is also an option, where there is capacity, to have face-to-face workshops for Years 2, 5 and 6 which build and consolidate the messages in the films. These are also free of charge and delivered by the NSPCC School Service Volunteers.

There is also a SEND version of the programme for



children with moderate learning disabilities, autism spectrum conditions or other additional learning needs.

Secondary Settings



Building Connections is an online service for people up to the age of 19 who are experiencing loneliness.

Across 11 sessions, participants work through a seven-step strengths-based approach programme with a befriender.

The service believes in a young person's right to early intervention if they are experiencing or struggling with the impact of loneliness and poor relationships, which sometimes lead to other severe mental health needs like anxiety, low self-esteem, etc.

Each Building Connections session gives the young person tools that can support them and help them develop resilience and coping techniques.

Young people will need to be referred into the service by a professional within an organisation/agency that works with those children and young people.

Talk Relationships is a free resource that supports secondary school teachers and leaders to confidently deliver effective and inclusive relationships and sex education.

We want all young people to understand healthy behaviours in relationships and recognise their right to be safe, heard, and respected. And we want them to know how to get help from a trusted adult if they need it.

Talk Relationships includes:

- A free elearning course for teachers that addresses their specific needs when delivering relationships and sex education.
- A free elearning course, specifically tailored to school leaders, on implementing a whole-school approach relationships and sex education.
- 14 free ready-to-teach lesson plans and resources.
- 6 free SEND-specific lessons plans, adaptable for the needs of different students.
- A helpline dedicated to supporting secondary school educators with help and advice to deliver effective sex and relationships education.
- A whole-school approach framework to relationships and sex education. The framework is made up for five free documents that, when used together, will support school leaders to implement a whole-school approach to relationships and sex education, based on evidence and best practice.
