## **Training Policy**



The training courses in this programme have been identified through training needs assessment and help support RSCP priorities for 2022/23. These priorities are derived from a number of sources, including: Child Safeguarding Practice Reviews (CSPRs); responses to current and national developments; and feedback from children, young people, families and carers.

#### **Principles of RSCP Training**

Our programme is based on principles to ensure that training is:

- Child centred and incorporates and promotes children's rights, the child's voice, and ensures that their welfare is treated as paramount.
- Incorporates equal opportunities and antioppressive practice and reflects the diversity of the communities served.
- Promotes and places the child within the family and recognises the need for working together and in partnership with parents and carers.
- Multi-agency and promotes the need for interagency working to safeguard children from harm.
- Evidence-based and incorporates learning from research, and service user participation.
- Incorporating and supporting a variety of learning styles including experiential and reflection.

#### Audiences

Safeguarding children and young people is everyone's business, which means that audiences are large and diverse. This includes the whole of the children and young people's workforce and those working with their parents or carers across all sectors and disciplines.

The courses on this training programme are only available to those who work *predominantly or exclusively* with children and families in the London Borough of Redbridge.

#### **Quality Assurance and Evaluation of Impact**

Our training is quality assured in-line with the above principles agreed within our <u>Framework and Principles for Safeguarding Children Training.</u>

If you attend one of our training events, you'll be asked to complete an online evaluation and you'll receive your certificate of attendance after completing it.

Each course will offer resources and ideas to 'transfer' learning to your teams and cascade throughout your organisation. You may also find an observer accessing your course, undertaking an independent evaluation.

We will follow up targeted courses by contacting participants to establish the impact of the training we deliver on practice and outcomes for children, young people and families.

## **Notes for Training Attendees and Managers**



**Learners:** Please discuss and agree your attendance with your line manager (or appropriate individual if you are the line manager); you'll need to give us their details on the <u>online booking form</u>. Please ensure the training is appropriate to your role. Make sure you're free to attend the course applied for **in full** before booking.

Managers: Before agreeing a booking, please ensure you discuss the content of the course with the learner, how it will be applied in the workplace and its suitability for the learner in their role. You'll be copied into the email booking confirmation and certificate of attendance for your information. Please make a note of the date in your diary and consider a substitute to cover any unexpected absence or staff departure, as there is a charge for late cancellations. We don't make exceptions for operational reasons. Following the training, you may be asked how the training has contributed to practice and outcomes.

Fees: Our course fees are £65 per 'full day' and £35 per 'half day' training course in the classroom, and £65 per 'long' and £35 per 'short' training course online. The course fee for each course is payable by all except those working or volunteering for charities and will be invoiced using the billing details on the booking 5 working days before the training. The page relating to each event in the programme details what type of event it is. There is no course fee for attending events described as 'free courses' but one will be charged for non-attendance. No charges apply for free briefings.

#### **Cancellation Policy:**

- We only accept cancellations made in writing to redbridgescp.training@redbridge.gov.uk with a minimum of 5 working days' notice before the day of the course (not including the day of the course). We will confirm all cancellations in writing, usually within 3 working days.
- All other cancellations will be considered to be nonattendance and will not be eligible for a refund. The only exception to this is sickness on the day of the training, provided we are informed in writing (to the above email address), no later than the day of the course, by the learner's line manager or appropriate individual.
- If for any reason an organisation wishes to change the name on the booking, we must be informed of the name and email address of the new attendee, and who they are replacing, ahead of the course, to the email address above.

#### Non-attendance:

- If a place is booked and the learner does not attend, they will not be eligible for a refund. In addition, please note the following:
- Non-attendance at free courses will incur a course fee.
- Any non-attendance by those working or volunteering for a charity will incur a course fee.
- Course fees incurred due to non-attendance will be invoiced using the billing details on the booking after the training course.



#### What to expect from us:

- We'll send you confirmation of your booking by email (normally within three working days of receipt of your booking form), confirming the date, times, title and venue of the course, and the terms and conditions of the booking. If you don't receive a booking confirmation from us, you don't have a booking.
- Your booking confirmation will include a calendar entry attachment so you can add the date to your calendar.
- We'll send you another email, usually one week before the course, with a link to the training event (if it's online) and any pre-course reading materials you may need.
- For classroom training, we'll provide plenty of water and cups but we won't be able to provide any other refreshments.
- We monitor participation in our online courses. If you
  miss more than 15 minutes of the course, we will not be
  able to certificate your attendance or provide a refund.

#### What we expect from you (online):

- You will need to have a computer with a working internet connection, internet browser (Chrome, Safari or Microsoft Edge), microphone and webcam to take part. Please make sure your equipment is working properly.
- We require attendees to have their camera turned on throughout the training. Our online training is a virtual classroom and we expect attendees to be present and participating throughout. If you need to turn your camera off for any reason, please flag this in the chat.

#### What we expect from you (all courses):

- Part of your responsibility when attending training is to provide feedback. We'll send you a link to our online feedback form after your course. Upon receipt of your completed form, we'll send your certificate of attendance. A limit of three months to complete this applies.
- If we send any pre-course reading materials, we expect anyone joining the course to have read them prior to attendance.
- Prompt attendance is required by the 'Start' time indicated in your booking confirmation (we recommend joining the training at the 'Registration' time). The session will be locked to new attendees 15 minutes after the start time. Anyone who misses the course due to lateness will be turned away and will not be eligible for a refund.
- If you cannot attend the full course, this must be agreed in advance, in writing, by the RSCP. Any early departures not agreed in advance with the RSCP will be considered non-attendance and will not be eligible for a certificate of attendance or a refund.

## What training should I attend?



Your employer is responsible for ensuring staff and volunteers receive basic training to raise awareness of safeguarding (often known as **Level 1**). They may also offer additional 'in-house' safeguarding training specific to your responsibilities and setting.

This Programme provides multi-agency training at Levels 2 and 3, as outlined in the <u>London Safeguarding Children Partnership Training Competency Framework.</u> It supports the skills and knowledge needed to work effectively within existing guidance and procedures, such as <u>Working Together to Safeguard Children 2023</u>, the <u>Intercollegiate Document, 2019</u> for competences in healthcare and the <u>London Child Protection Procedures</u>.

**Level 2 Training** should be attended by practitioners who work predominantly, or have intensive but irregular contact, with children, young people and/or parents/carers.

**Level 3 Training** is more advanced and learners will have particular specialist child protection responsibilities which may include being a 'designated lead' in their agency for child protection.

# Examples of safeguarding responsibilities and professional competence

# London SCP Training Level 2

- Working together to identify, assess and meet the needs of children where there are safeguarding concerns
- To identify child focused interventions and measurable outcomes
- Understanding the possible impact of parenting difficulties on parenting capacity.
- Recognising the importance of family history and functioning.
- Working with children and family members, including addressing lack of co-operation and superficial compliance.

# SCP Training Level 3

London ;

- Attending Child Protection Conferences and managing Core Groups; roles, responsibilities and collaborative practice.
- Using professional judgements to make decisions as to whether a child is suffering, or is likely to suffer, significant harm.
- Working with complexity.
- Taking emergency action or intervention.
- · Promoting effective, professional practice.
- Supervising child protection cases and advising other professionals.



# **Understanding Safeguarding Risks**

Learning within our programme has been developed through ongoing training needs analysis carried out at a local level by the Training Subgroup of the RSCP and draws on feedback from our multi-agency learners.

This section of our programme contains courses on a range of risks faced by children, using lessons learned from incidences of significant harm found in the latest <u>Triennial Analysis of Serious Case Reviews 2020</u> and recent <u>Child Protection Case Reviews</u>. It features key learning on those children most vulnerable to harm and links to the local services and practitioners supporting early intervention and support for families.



# Cost of Living Crisis, Poverty and the Effects on Parenting and Children's Mental Health

#### **Background**

Poverty increases the risk of mental health problems and can be both a causal factor and a consequence. Mental health is shaped by the wide-ranging characteristics (including inequalities) of the social, economic and physical environments in which children and their families live.

Everyone working in the children and families workforce will benefit from developing their knowledge and awareness of the effects of family poverty.

#### **Learning Objectives:**

- Describe some of the emotional and psychological impacts of poverty and social exclusion on the lives of families with children
- The way that practitioner interactions with families can reenforce or relieve feelings of blame and disempowerment.
- The types of support that can help mitigate the impact of poverty on parenting and children's outcomes.

## **Domestic Abuse and Safeguarding Children**



#### **Background**

The trauma that children experience when they witness domestic violence in the home plays a major role in their development and physical well-being, effects of which can last into adulthood. The <a href="Domestic Abuse Act 2021">Domestic Abuse Act 2021</a> recognises children as victims of domestic abuse rather than witnesses.

Domestic abuse can also be a sign that children are suffering another type of abuse or neglect.

#### **Learning Outcomes**

At the end of this training participants will be able to:

- Define domestic abuse considering its breadth and manifestations
- Identify the impact of domestic abuse on parenting capacity.
- Link the effects of domestic abuse on a child's welfare and development.
- Use relevant knowledge in effective engagement with families where domestic abuse is an issue.
- Identify the multi-professional roles in meeting the needs of children and families affected by domestic abuse.
- Understand local support and safeguarding procedures for those affected by domestic abuse and their children

### **Fabricated and Induced Illness**



#### **FREE BRIEFING**

#### **Background**

The majority of parents have the best interests of their child at heart. However, there is a rare form of child abuse called Fabricated and Induced Illness (FII), where a parent or carer exaggerates or deliberately causes symptoms of illness in a child. This briefing explores this safeguarding issue and multi-agency responses.

#### **Background**

The <u>Independent Inquiry on Child Sexual Abuse</u> has heard from victims and survivors of the psychological and physical effects on well-being, family and intimate relationships, faith, and education and career. For some victims and survivors these effects endure throughout adult life.

This half-day training aims to provide a space for front line professionals to understand local services and reflect on the support needs of children and families affected.

## **Radicalisation Awareness Workshop**



#### **Background**

This half day interactive workshop aims raise awareness among frontline staff of radicalisation and the risks associated with the targeting of vulnerable individuals by extremists.

The session covers local and national context and threats, the process of radicalisation, and factors which may contribute to an individual's susceptibility to radicalisation. Topical examples will be used as illustrations and case studies to understand the referral process.

# Safeguarding Children from Honour Based Abuse and Forced Marriage



#### **Background**

So-called honour-based violence is an international term used by many cultures for the justification of abuse and violence. Honour-based abuse can go hand in hand with forced marriages, affecting young men and young women. The national Violence Against Women and Girls (VAWG) Strategy has identified honour-based violence and forced marriage as a focus, as the very nature of it increases the likelihood of this abuse going underreported.

#### **Learning Outcomes**

By the end of this course participants will:

- Understand the definitions of honour-based abuse and forced marriage and the impact on children.
- Have explored cultural issues and community beliefs regarding honour and marriage and the differences between "arranged" and "forced" marriage.
- Be able to recognise forms of honour-based abuse and identify risk indicators in an agency setting.
- Be able to identify practice issues with regard to cultural sensitivity, community beliefs and religion.
- Gain an understanding of the Forced Marriage Protection Orders and criminal legislation.
- Have looked at case examples.
- Be aware of the local safeguarding referral processes and both national and local support agencies.



## **Safeguarding Privately Fostered Children**



#### **Background**

Private fostering is the term used when someone who is not a parent or a 'close relative' (e.g. great aunt, cousin, mum's friend or a neighbour) cares for a child or young person in their own home. The Local Authority has a duty to safeguard and promote the welfare of privately fostered children under the Children's Act 2004.

Many private foster carers and parents are not aware of their obligations and, as a result, many private fostering arrangements remain hidden, leaving the children who have been placed with them without the benefit of formal monitoring arrangements.

# Contextual Safeguarding and Child on Child Abuse

Safeguarding adolescents is one of the RSCP's priorities. Courses in this section of our programme seek to equip participants to understand and respond to the 'context' of where and when young people can experience significant harm beyond their families. It recognises that the different relationships young people form in their neighbourhoods, schools and online can feature violence and abuse.

Parents and carers may have little influence and insight into these contexts, and young people's experiences of abuse and exploitation outside the home can damage parent-child relationships.

Contextual Safeguarding, therefore, expands child protection beyond traditional sectors, to any professional and volunteer with influence and opportunities to address the abuse young people experience beyond their front doors.

# **Understanding Thresholds and Making Referrals**



**FREE TRAINING** 

#### **Background**

I 2

Department for Education (DfE) research into Serious Case Reviews identified that 'thresholds' for intervention can vary between agencies; differences in perceived thresholds can lead to frustration or breakdown in effective working, resulting in children falling through the gaps or their needs not being met. Reports have also emphasised the importance of supporting professionals with their duty to escalate concerns.

In Redbridge, the London Safeguarding Children Partnership's multiagency document, Threshold -Continuum of Need Matrix, sets out the thresholds for referral for use by all agencies and professionals who are worried or concerned about a child's safety or welfare. This course aims to support front-line workers and managers in its use. The course will also refer to the RSCP's Resolution and Escalation Policy, which aims to promote a culture of partnerships, working by supporting professionals to address differences in professional judgements around the response to the safety and wellbeing of children and young people.

#### **Learning Outcomes**

By the end of the training, participants will:

- Be able to describe and understand the 'levels of need' that will be applied to determine whether the child and family can be appropriately and safely helped by early intervention and family support services.
- Have discussed indicators of different kinds of risk within these levels.
- Know how to access services for children with different levels of need effectively, and what kind of response can be expected.
- Understand the components of a good <u>Multi-agency Referral Form</u>



# Working Together to Safeguard Children – a Shared Responsibility (Safeguarding Level 2)



#### Background

# RSCP Designated Safeguarding Lead (Safeguarding Level 3)



### **Background**

This course is for those who manage or supervise those who work with children and families. It will consider the legislation and practice guidance that supports your responsibilities as lead in safeguarding and further develop your knowledge and skill of working in partnership with other agencies and professionals supporting children and their families involved in early help and child protection. To attend this course, we require you to first complete our Level 2 Training, Working Together to Safeguard Children – A Shared Responsibility.

#### **Learning Outcomes**

By the end of the training, participants will:

- Recognise and challenge their own values regarding abuse and maltreatment and its impact on professional practice.
- State the processes needed to ensure a safe environment for children.
- Recognise barriers and challenge blocks to disclosure of abuse
- Understand the actions to take when informed of concerns, including concerns regarding staff or volunteers.
- Understand the Early Intervention Process and the workings of the Multi-Agency Safeguarding Hub
- Consider the referral process and what further role they may have in plans to safeguard children
- Demonstrate an awareness of the emotional dimension of safeguarding work and identify a network for support within their organisations
